#### **Previous Minutes**

#### Resignation

Ms Lyn McCreadie has formally resigned from the Community Council

#### Police Report

Sergeant Julie Mac Donald of Police Scotland indicated that there has been a number of minor crimes including 2 thefts from cars, fraud, drugs offences, 4 shopliftings, 1 house break in, 1 car stolen, 2 breach of bail,4 traffic offences. The foregoing crimes are considered very low and approximately 50% were caught. Mrs T McIntyre raised the issue of traffic congestion and potential for accidents at Clober Primary School due to parking outside school by parents dropping off children despite letters to all parents. The Council are looking to introduce a temporary one way system at peak traffic periods. The police were requested to mention the foregoing traffic safety problems to their colleagues

## **Treasurers Report**

Mrs M Prentice presented her report which highlighted that in the Community Account there was approximately £600 and in the Administration Account there was £7242.00.te their project. Accounts have been submitted to Auditor and approved and sent to EDC. Chess Club has requested £200 and after discussion it was agreed to send application forms to be returned for their grant. MMM have been submitting minor invoices for expenses and Treasurer was asked to prepare a statement for next meeting detailing invoices and grants made to MMM as the Council will have to discuss additional and anticipated expenditure.

#### **Councillors Report**

The Councillors submitted a written report and the following issues were highlighted

- At a special Council meeting The Fire and Police service were questioned about their past performance.
- 2) EDC will support efforts to celebrate 250 anniversary of Thomas Muir
- 3) Planning permission granted for a restaurant at the wedding shop
- 4) Tower Road playpark to be upgraded.
- 5) EDC to meet Road Officers on specific issues
- 6) Housing repair contracts are progressing with minor issues being resolved.
- 7) In response to a question Jim Gibbons indicated that the newly installed black bollards installed in the precinct were to stop vehicles going to close to the bridge parapets as advised by EDC Engineers to safeguard the structural integrity of the structures

- 3) Clober Road application for housing has been refused
- 4) Drumclog Avenue clarification required about further documentation
- 5) Draft Active Travel Strategy MCC to submit a report by 7 October

There was particular concern about the Road/Cycle Way improvements to the A81 in particular no turning points. entering and exiting cycle lane, priority movements, road markings etc and in general MCC thought it was dangerous and hazardous and a waste of money. Roads Department officials would be invited to next meeting

Allison Bain indicated that the Health and Safety Commitees will be merging due to EDC budget cuts

#### **Facilities**

Caroline Diaz highlighted that there is a severe lack of sports facilities in Milngavie

Particularly for the disabled and Maureen Henry will invite Mark Grant along to next meeting to discuss the foregoing. It should be noted Caroline for her volunteer work has been awarded a National and Local Achievement Award in Disability Football
